LETTER OF BIO-MEDICAL WASTE AUTHORISATION


[Authorisation for Generation, Collection, Reception, Segregation, Storage, Transportation, Treatment, Disposal of Bio-Medical Wastes under Rule 7(4)]

- I. File number of authorisation and date of issue:
No.MPCB/PAMS/BMW/NM- 4350-12/NM- 05 /2013. Date: 22/01/2013
- II. M/s. Mumbai Waste Management Ltd is hereby granted an authorisation for operating a common Bio Medical waste treatment & disposal facility on BOOT (Build, Own, Operate & Transport) basis with Navi Mumbai Municipal Corporation on the premises situated at P-32, MIDC, Talaja, Tal: Panvel: Dist: Raigad, Maharashtra - 410208.
- III. This authorisation shall be in force for a period up to 31/12/2017. An application shall be made by the occupier/operator for renewal 3 Months before expiry of earlier authorisation.
- IV. This authorisation is issued subject to compliance of the conditions stated below and to such other conditions as may be specified in the Rules for the time being in force under the Environment (Protection) Act, 1986.

Terms and Conditions of authorisation

1. The authorized Person shall comply with the provisions of the Environment (Protection) Act, 1986, and the Rules made there under.
2. The authorisation shall be produced for inspection at the request of an officer authorized by the prescribed authority.
3. i) The authorized person shall not rent, lend or sell the biomedical waste or facility.
ii) The authorized person can transfer the BMW generated at above premises to the "Transporter" or "Operator of Facility" authorized by MPCB under Bio-Medical Waste (Management and Handling) Rules, 1998 for collection, transportation, treatment and/or disposal of BMW generated.

15. When any accident occurs at any institution or facility or any other site where BMW is handled or during transportation of such waste, the authorized person shall report the accident in Form III to the prescribed authority forthwith.
16. M/s. Mumbai Waste Management Ltd, P-32, MIDC, Taloja, Tal: Panvel, Dist: Raigad, Maharashtra – 410208 shall provide Effluent treatment Plant for the treatment of effluent generated from their facility, within six months from date of issue of this authorization.
17. M/s. Mumbai Waste Management Ltd, P-32, MIDC, Taloja, Tal: Panvel, Dist: Raigad, Maharashtra – 410208 shall submit the Bank guarantee of Rs. 20 Lacs within 15 days from the date of issue of this authorization towards compliance of condition at sr. no 16 in the authorization letter.
18. The Occupier will obey all the lawful instructions issued by the Board Officers from time to time.
