## CONSENT TO ESTABLISH

**Consent to Establish** under **Section 25** of the Water (Prevention and Control of Pollution) Act, 1974, as amended; under Section 21 of the Air (Prevention and Control of Pollution) Act, 1981, as amended and Authorization under Rule 5 of the Hazardous Wastes (Management Handling & Transboundary Movement) Rules, 2008, as amended, notified under the Environment (Protection) Act, 1986 [To be hereinafter referred as Water Act, Air Act and HW Rules respectively] is hereby granted to

**M/s. Mumbai Waste Management Ltd.**  
(SVP of M/s. Ramky Group)

To operate a common facility as an operator for Collection, transport, storage, treatment and disposal of composite hazardous wastes (hereinafter referred as **CHWTSDf**) subjected to the following conditions :-

1. The **Consent to Establish** is granted **as an Operator of the facility** under Rule 5 of Hazardous Wastes (Management, Handling & Transboundary Movement) Rules, 2008 to set up common hazardous wastes collection, transportation, storage, treatment and disposal facility (CHWTSDf) at Plot No: L-34/45 (P), Addl. Mahad MIDC, Dist. Raigad, Tal. Mahad. Maharashtra.

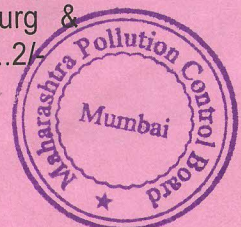
2. The Consent to Establish is valid for the period up to **Commissioning of Facility**.

3. The installed and operating capacity of the CHWTSDf shall be as under:-

[a] **Secured Landfill** : **20,000 MT/Year** (Stabilization and landfillable Hazardous Waste.

4. The CHWTSDf shall cater to the requirements of environments of environmentally sound management as required under the HW Rules for the hazardous wastes generated by the industries possessing valid authorization by Maharashtra Pollution Control Board (MPCB)

[a] Industries located in Alibaug, Karjat, Mahad, Mangaon, Mhasala, Poladpur, Pen, Shriwardhan, Sudhagad, Talukas of Raigad District. Sindhudurg & Ratnagiri District.






37. All the conditions of this Consent shall be strictly implemented and the consent order shall be displayed at a prominent location in the factory premises.
38. This is issued subject to said site identification and notification to be issued by Gov. of Maharashtra / Maharashtra Industrial Development Corporation.
39. **You shall make the appropriate provisions towards maintenance of Escrow account / Corpus funds / contingency funds / insurance policies etc. for post monitoring of CHWTSDF.**
40. The applicant shall comply with the conditions stipulated in Environment Clearance granted by GOM, vide no: **EC-2009/CR134/TC2**, **dt: 21/05/2010.**
41. This is issued subject to decision taken in the meeting of the Consent Appraisal Committee of the Board held on, **dt: 9/08/2010.**
42. The capital investment of the unit is **Rs. 10.93 Cr.**
43. This is issued subject to Technical and Financial approval by the Competent Authority.
